Frontier GREAT Grant Update



- Frontier GREAT Grant (\$3.8M grant, \$4.3M project)
 - Engineering and permitting complete
 - Wire center (headend) construction complete (2 facilities)
 - Fiber construction began last fall
 - Construction has been most active north of Franklin
 - Now seeing construction activity south around Otto
 - Anticipate connection of homes/businesses starting in June

BalsamWest Update



- BalsamWest GREAT Grant (\$1M grant, \$1.2M project)
 - Builds from south Macon broadband expansion 2020
 - Engineering and permitting complete
 - Fiber construction began this spring around Otto
 - Additional construction is also beginning around Scaly Mountain
 - First batch of 35 addresses in Otto activation in ~3 weeks

- Nantahala serving 42 residences and 3 businesses
- Macon County businesses (other than Nantahala) serving ~96
- Macon County residential fiber (other than Nantahala) serving ~176

Charter RDOF Subsidy



- Charter Communications RDOF Subsidy through FCC (\$9M subsidy 2022)
 - No evidence yet that Charter has begun construction in Macon County
 - No update from Charter since January
 - Future of RDOF program is uncertain given changes at the FCC
 - We are still hopeful Charter will begin deployment this year

CAB Grant Award



- CAB Round 1 agreement with BalsamWest (July 2025) fell through
- CAB Round 2 award made to Frontier in March 2025
 - \$2.3M grant, \$3.4M project, no County match required
 - Project to serve 411 homes and businesses in Sanderstown area
 - Official agreement completed in May 2025
 - Builds off Frontier GREAT project already underway
 - Projected completion by December 2026

Cowee School Public WiFi



- Cowee School is an award location under the Frontier GREAT grant
- Largest anchor institution in Cowee with county-wide impact
- Upgrade network at facility for public WiFi and education programs
- Utilizing a \$25K grant through Southwestern Commission (funding from Dogwood)
- Combining this grant with \$6K remaining from Nantahala project
- Expect fiber connection within the next couple of months

Future Broadband Grants



- North Carolina GREAT and CAB slated to continue in 2026
- Funding for these programs to be sourced by the federal IIJA legislation
- Broadband funding through \$42.5M BEAD program
- Program administered by the NTIA grants awarded by states
- Current administration expected to make changes to BEAD program
- Outcome uncertain impact could be minor or significant
- All state broadband offices nationwide on hold pending changes
